Application Frequency:

One application per year

Application Sites:

Turfgrass, landscape and mulched areas, outdoor containerized nurseries, structural perimeter and boundary applications, and individual fire ant mound treatments

Key Application Tips

- Apply once annually at 87 lb/A (2 lb/1,000 ft²) for season-long fire ant control. Do not make more than one application per year.
- Apply when the grass is dry, then water in lightly immediately following application.
- If soil is dry, water prior to treatment to maximize fire ant control. The residual control of fipronil will be slowed under dry conditions.
- For established fire ant populations, broadcast treatments can be used in combination with mound treatments for enhanced control.
